#### 5. Achievements

During the meeting, IPG representatives engaged in productive discussions and strengthened relationships with the management and partners of MRAP's offices in India, Singapore, Hong Kong, Malaysia, Indonesia, and the Philippines. The networking and trust-building efforts with the leadership of MRAP's various branches were considered significant achievements. Furthermore, Nobani & Marouf, C.P.A. from Jordan, newly joined MRAP's network. This expanded MRAP's presence into the Middle East, covering countries such as Saudi Arabia, the UAE, Egypt, Iraq, Syria, and Oman. MRAP's expansion into the Middle East is also highly valuable for IPG, given the scarcity of member firms covering this region within the IPG network.

# 6. Challenges

While the annual meeting was generally successful, a comment was made concerning the relationship between IPG and MRAP. The comment highlighted the need for ongoing assessment of the effectiveness between IPG, primarily a network of law firms based in Europe, and MRAP, which mainly focuses on accounting services based in Asia. Needless to say, IPG is a group of various professional firms, including not only law firms but also accounting firms, audit firms, and other advisory firms. This concern is not serious or urgent. However, we need to activate further cooperation among member firms of accounting and auditing firms while demonstrating our strength as a group of firms that have diversity.
